- The institution has a report card; the presidents of the Mississippi Community College system approved a new report card last week
- The data presented today is required by SACSCOC...Student Rights to Know (crime rates, athletes rate, student success rate) must be published
- Report card was initially intended to move us towards performance base funding by 2020
- Success indicators the same as required by federal, state, and local governance
- We are now a part of ATD Achieving the Dream which will direct our focus towards student success and a student-centered culture and serving the whole student; our local team will visit ATD Kickoff in June
- The goal is to make every QEP team member is totally engaged in ATD (helping students get to the finish line... graduate, transfer)
- The Report Card: The increase of 505 in 2015 for total degrees awarded is due to the stackable credentials in CTE
- The goal is to consistently increase in student success

- How to access the changes in the fluctuation of success...the process is to look at what students said on the surveys about the services you provided and try to improve
- Quality Control person is needed...IE does it

- Student Progress...based on first-time full time or first-time part-time students (report card data is based on such)
- We do not assess why the student is here (admission application)
- Credit Hours Completed of the hours attempted
- Remediation Readiness Success...passing the dev ed courses and moving into the gen ed courses
- 21 or older we do not assess...the faculty senate should push for a change, not assessing is a disservice to our students

- The difference in the numbers in the GED dropped because the test was moved to online and the cost increased
- Participants with a measurable skill gain...at skill tech you go from level to level to level if you finish the program out
- Course Completion Rates...Academic (sites and dual enrollment), CTE (programs), HS (program)
